We invite you to consider service on the Board of Directors for River Plantation Community Association. Pursuant to the Association's bylaws, there are four director positions of which three directors have three-year terms and one director has a one-year term expiring. The four officers are Jamie Goodman, Mike Lee and Steve Dresel and Annie Altenhofen. The election to fill these 4 positions will be held at the Homeowner Annual Meeting on January 25, 2018 at 6:30 p.m. at Cornerstone Church, 100 Mosswood Drive, Conroe Texas 77302.

Three candidates receiving the highest number of votes at the January election shall receive three year terms and one candidate will receive a one year term in this election. Once the new Board members are elected, the elected Board members will appoint its officers in accordance with our bylaws. In order to be eligible to serve on the River Plantation Board of Directors, you MUST be a property owner in good standing and it shall be incumbent upon the candidate to supply proof of said ownership. Candidate must not have a felony conviction or a conviction involving a crime of moral turpitude, unless said conviction is older than 20 years

A strong and active Board is the hallmark of a great neighborhood. These positions are important and take commitment and time when serving. We ask that you consider this when nominating. Upon election, Board members will be requested to sign a code of conduct and confidentiality agreement.

If you are interested in running for a position on the Board please submit the attached form that will be shared with the membership, and return it to the Association either by mail to 451 River Plantation Dr. Conroe, Texas, 77302, by email at [rpcia@consolidated.net](mailto:rpcia@consolidated.net) or drop it in the drop-box at the back of the RPCIA building. Upon receipt of your nomination, you will be notified to confirm your nomination. The nomination form will need to be submitted no later than December 15, 2017.

The absentee ballot will contain the names of the candidates who submitted their names as nominees, pursuant to this letter.
